## LOTTIE & CATCHINGS SMITH

**A**fter serving months and months in the Pacific during World War II, Catchings Smith knew he was ready for city life.

But as a University of Virginia nongraduate, he also knew he needed to complete his education. Upon his discharge from the U.S. Army Air Corp in 1946, Smith found a university that offered both an exciting city life and an excellent education. He enrolled in Tulane's business school.

It was the right decision, he says.

"I met my wife at Tulane, I had some great professors—particularly in finance and marketing—and I made great friends through my fraternity, Sigma Chi," says Smith (BBA '49). "I really have many fond memories of the time I spent at Tulane and in New Orleans."

Smith and his wife, Lottie Lee Smith (N '49), have kept close ties

with their alma mater over the years. He was president of the Jackson Tulane Alumni Club, a member of the Alumni Affairs Committee and a regional fund chair. She served as Deep South representative for the Newcomb Alumnae Association's advisory board from 1990 through 1992.

The Jackson, Miss., residents have also been generous donors to the university. They recently dedicated a third of their IRA to be split equally between the A. B. Freeman School of Business and Newcomb College. By designating the university beneficiary of part of their IRA, the Smiths are taking advantage of two tax benefits. The first is an estate tax deduction, and the second is that the IRA distribution to the university is not diluted by income taxes, as would have been the case had individuals been named beneficiary. Choosing to support their alma mater this way simply made the

most sense, says Smith, a retired vice president of Merrill Lynch.

"This was a good way to do two things: To help save taxes and to make a donation to the organizations of our choice," Smith says. "We wanted some way to give back to Tulane and this was a smart way to do it."

The Smiths have specified that their donation is to help provide improved programming for students in the Theater Department and the School of Business. "We just want to help increase the students' educational opportunities," Smith says.

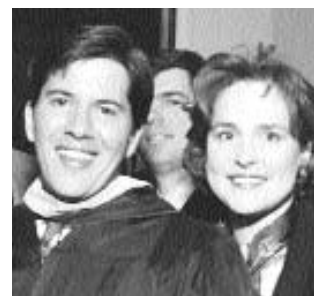

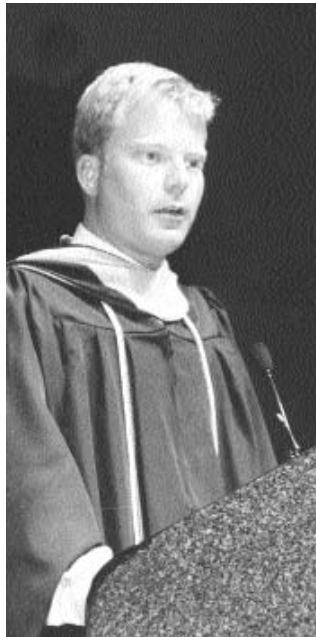
